# City of Chicago Holds Budget Hearing on Westside

Tuesday, the City of Chicago Preliminary Budget meeting was held on at the Mayor's office for People with Disabilities Chicago Department on Aging Central West regional Center at 2102 W. Odgen. The second of three, the final hearing being held on Thursday August 30 at the Laughlin Falconer Elementary School 3020 N. Lamon, was packed with city departmental staff, the Mayor and city residents supporting and speaking out on their specific agendas.

The City of Chicago is focusing on getting together a budget by November that not only focuses on the cities needs as a whole, but can specify targeted areas for city funds that can be allocated to improve its neighborhoods.

Mayor Daley's beginning speech

targeted the state of Illinois' funding of education as not meeting the needs of the city. The mayor stated that we have a majority of children that are poor in the Chicago Public School system and the tax base is not as sufficient as the suburban area." Every year that they don't fund .... We have to go to the local taxpayer to ask them will they fund it. It simple as that, said Mayor Daley."

Specifics of the proposed budget include an increase in funds for the CEDA Low Income Energy and Assistance Program as well as increases in funding for the fight against the cities growing poverty and homelessness epidemic. However, several CPS program cuts are shown in the proposed budget. A copy of the



# Catalyst Charter School Receives Award for Academic Excellence

Last Thursday, at Donoghue Charter Public School, North Lawndale's own Catalyst Charter School was honored at the second annual Charter Up! Celebration for its excellence in extracurricular activities. The school was most noted for a program on its Howland Campus called Footworkin', in which kids are taught a Chicago-born dance style incorporating tap, break, and African tribal dance.

There were four schools recognized by the Illinois Network of Charter Schools (INCS) including: Catalyst Charter School, Pritzker College Prep, Providence Englewood Charter School,

and SIU-E East St. Louis Charter School. The nominees were

selected by a committee of experts in education, child development, literacy, vocational training, community development, and the humanities. The awards were given to charter public schools with innovative programs that encourage learning in unique and engaging ways.

"Our goal is to recognize charter public school programs that exemplify the spirit of innovation that drives charter public schools to success, helping them to achieve high, measurable standards," said Nicolas Crawford, a senior from North Lawndale College Prep who spoke at the event.

Footworkin' is part of Howland's mandatory Renaissance Program which, according to sixth grader Mark



# **CHARGES PENDING IN COP SHOOTING**

Chicago police department spokeswoman Monique Bond told the North Lawndale Community News (NLCN) that charges were pending against a man who was shot by police who attempted to question him late Thursday (Aug. 23) on the city's West Side.

The unidentified man was rushed to Mt. Sinai Hospital and Medical Center where he was being treated for a single gunshot wound to the neck. He remained hospitalized under police guard at NLCN press time late Friday.

Bond said officers from the department's Targeted Response Unit (TRU) approached the man wearing a heavy winter coat near the corner of Jackson and Springfield just after 10:30 p.m. "Any type of heavy jacket being

worn in warm temperatures like this is obvious to a police officer that something is being concealed," Bond said.

She said the officers approached the man who immediately ran north towards Wilcox Street, ensuing a foot chase that stretched at least a half block when the officers commanded the man to stop. After discarding two plastic bags containing cocaine and heroin, she said the man then turned in the direction of the pursuing officers and lifted his jacket while raising his right hand as if he were pulling out a weapon in the direction of the officers.

"The officer, believing that the man was going to shoot and in fear of his life, fired once," Bond said.

She said police did not recover a weapon and the department's Office of Professional Standards was reviewing the shooting. Included in the investigation is a review of a policemounted camera located on West Wilcox.

"Any time there is a police shooting, there are concerns," Bond continued. "But the police are concerned, too, because we have a dangerous job to do and we have to make a split-second decision.

Police did recover the two plastic bags containing cocaine and heroin.

Bond noted that this was the 28<sup>th</sup> shooting of civilians at the hands of Chicago police this year. But, she said, "It sounds like a lot, by comparison to Los Angeles, which

has had 31 shootings.

# THE CHICAGO TRANSIT AUTHORITY BRACES FOR TROUBLE

The Chicago Transit Authority (CTA) proposed a Doomsday Budget Plan that will go into effect to combat its financial problems. Pace and Metra also face financial problems.

According to Harry Brooks, Transit Historian, of the Little Village Environmental Justice Organization (LVEJO), the CTA has a budget deficit of \$110 million deficit that needed to be cut by July.

"I can not pull any more rabbits out my hat," said CTA President, Ron Huberman. Huberman's frustration underscores the transit agency's dire situation and the growing possibility of drastic cuts.

The CTA will have to raise fares and cut services in order to continue providing

Chicago's commuters with public transportation because it can not generate enough funding itself to adequately service a large city such as Chicago. The Doomsday Budget Plan will entail the cutting of 39 bus routes, mainly the express routes, such as the X28 Stoney Island, X4 Cottage Groove, X20 Madison, X49 Western, X64 Cicero, and the 53A South Pulaski limited. In addition, fare hikes will include a "bus ride to be \$2.50 with no transfer" and "a train ride to raise to \$3.00 during rush hour from 6:00 a.m. to 10:00 a.m. and 4:00 p.m. to 7:00 p.m." and "after peak hours a train ride would cost \$2.50," said Mike Pitula. Also, let's not forget about the possible closings of the Yellow Line and

Purple Line and the elimination of 700 CTA employees.

"Pace on September 1 will be the first to raise fares and will cut para transit services," said Mike Pitula, Community Organizer for Public Transportation for the LVEJO. "The reason being is that "all three agencies CTA, Pace and Metra all operate as independent agencies and have no coordination," said Mike Pitula.

But, there maybe an alternative to CTA's proposed Doomsday Budget Plan that could help CTA generate enough monies to trim its enormous deficit. In Springfield lawmakers are trying to get Bill 572, that's already passed through the House of Representatives, passed

through the Senate that would "include amendments to help raise taxes that would provide CTA with enough funding," said Mike Pitula. But, current Illinois Governor, Rob Blagojevich, recently stated that he would "not raise taxes," so the chances of Bill 572 being passed is not likely and is threatened to be vetoed by the Governor.

Also, there is a push for "bipartisan support in Collar Counties, such as Dupage, to increase sales taxes to help generate funding for the CTA that would include one half of one percent or 50 cents taken out of every \$100.00 made" and in non-Collar Counties "one quarter of one percent or 25 cents taken

#### MAN TAKES BEAT-DOWN FOR

A 31-year-old man was hospitalized late Friday after he told police he was beaten by at least three men armed with a baseball bat.

The unidentified victim told police he was approached by the trio in the 1600 block of South Homan Avenue just after 2:00 p.m. Thursday. After refusing to comply with a demand that he give up the hat he was wearing, the trio proceeded to beat the man about the head and body, according to police department News Affairs spokeswoman Officer Laura Kubiak.

Area 4 investigators are seeking three male Blacks, ranging in age from 18 to 25, who are believed to be responsible for the beating.

# SUNDAY SHOOTING DEATHS INVESTIGATED

Area 4 Homicide Investigators were without an arrest or motive in the shooting death of a 28-year-old man, who was discovered by police lying on the ground outside a building in the 700 block of West Lake Street.

The Cook County Medical Examiner's office identified the victim as Omari Houston. He was pronounced dead on the scene early Sunday (Aug. 19) morning after sustaining a single gunshot wound to his side.

In an unrelated shooting death, a 25-year-old man was discovered shot to death in a car parked in the 500 Block of South Lockwood Avenue just after 1:00 a.m. Sunday (Aug. 19).

The Cook County Medical Examiner's office identified the victim as Shaun Wooden of the 5300 block of West Congress Parkway. He was pronounced dead on the scene from his wounds. Area 4 Homicide Investigators were without an arrest or motive in the

shooting.

# CAUSE OF WOMAN'S DEATH UNDER INVESTIGATION

The Cook County Medical Examiner's office continued its investigation into the death of a 42-year-old woman, who complained of trouble breathing late Monday (Aug. 20) at her residence in the 1300 block of West 15<sup>th</sup> Street.

The unidentified woman was rushed by Chicago Fire Department paramedics to John Stroger, Jr. Hospital where she was pronounced dead shortly after arriving. A police report indicated the death was being investigated as a non-criminal death.

#### MAN CRITICAL FROM SHOOTING

A 38-year-old shooting victim was listed in critical condition after sustaining a single gunshot wound to the back while walking down the street in the 2300 block of South Damen Avenue early Tuesday (Aug. 21) afternoon.

Police said the shooting occurred just after 2:45 p.m. when an unknown gunman approached and shot the victim before fleeing westbound on Blue Island Avenue. The unidentified victim was rushed via ambulance to John Stroger, Jr. Hospital where he remained late Friday. Area 4 Violent Crimes investigators were without an arrest or motive in connection with the shooting.

# DRUG RING INDIVIDUALS SOUGHT

Chicago police said on Friday that they are still seeking seven individuals who have been issued warrants in connection with an open-air drug market that operated in the East Garfield community.

Police department News Affairs spokeswoman Officer Laura Kubiak identified those being sought as 26-year-old

#### THEATRE REVIEW: APOLOGY FROM ONE SISTA TO ANOTHER

Apology explores issues including the exploitation of needy and vulnerable women, loneliness, maturity, self-esteem and idealism. This was well accomplished with fine writing, excellent acting, avoiding stereotypes and simplistic judgment. The characters are true to life, yet also invested with the agony and poetry of the human soul.

Brian has a good front and rap. Behind that he is a skilled manipulator who plays all the chords; charm, flattery, threats, brutality – and vulnerability. He works two women like a magician performing card tricks. Meeting Rita in an online chat room he enters her life and lays down his main game: claiming to be an experienced entrepreneur who needs investment in his projects. Rita's friend Sophie is on the rebound from a bad relationship so Brian plays her as well.

Rita escapes but Sophie gets the full treatment. Brian attacks her self-esteem, isolates her from her friends, beats her and tells her he will attack her family. He sees her increasing drug dependency as just another tool to hold her down. Charles, a true friend, tries but fails to help. This posse of associates hangs out at the Poetry Slam Café. Not incidentally, the poetry recited at the Café is strong and musical while speaking to the issues and dynamics of the play.

Sometimes the actors step out of character and address the audience directly in verse. The fine poetry is perfectly fitted into the plot and character development of the story. As one of the main characters lies dead at the end of the play, his living alter ego stands over the body and delivers a beautiful eulogy in rhyme. The actors in this ensemble are all outstanding, making the audience flinch at some of the powerhouse scenes.

At the conclusion, the author, Shywanee Manson (and director) took the stage and introduced the actors: Safia Jalila, Brandon Battle, Lana Cromwell, Mel Roberson, Robert Herron and Tara Brown. Richard Reed displays depth as the cruel but conflicted

Brian. Ameena Chapman's Rita matures during the course of the play; as the tragic Sophie, Toya Turner gives a performance of remarkable depth. In a supporting role, Andre Truss plays Tyrone who has graduated from selling reefer to what he calls H TWO OH. He displays the confidence, moves and stage presence of the late, great Sammy Davis, Jr.

At the impressive Herman Hall theatre of the Illinois Institute of Technology, *Apology* completed its current run on Sunday, September 26 Earlier, the play was nominated for best theatre performance by the Chicago 2006 Truth Awards. The production team of Itua Irumundomon and Brian Water are negotiating with other venues to transfer *Apology*, a play engaging contemporary life with depth and compassion. out of every \$100.00 made' said Mike Pitula. Also, the notion of real estate taxes contributing to the funding of CTA is an option that would include "house buyers and sellers contributing once or twice in their lifetime" and "those that are in more contact with real estate transactions would contribute more," said Mile Pitula.

Now that CTA will have resort to such drastic measures North Lawndale Community (NLC) and neighboring communities like Little Village will have to network with each other to ensure that residents will have transportation to commute throughout the city and the suburbs. So, the LVEJO has proposed to start a "Rider Organization" that will "build unity between riders and CTA drivers" and will advocate "no more fare increases, no lay offs and no service cuts," said Mike Pitula.

Evans Jr., emphasizes the importance of education beyond the classroom.

"Other than the academic things we do at Catalyst, the Renaissance Program is where we can do things like art, and other academic achievements that will help us when we grow up," said Evans. "Other than skills in math, science and social studies, we'll also have skills from Renaissance."

Charter public schools are governed by non-profit boards of directors that encourage

academic autonomy and community engagement. The 35 Charter Public Schools across Illinois serve over 19,000 students, of which 80 percent are from low-income families. Although separate from traditional public schools, INCS Executive, Elizabeth Evans, hopes these new programs will be shared with public schools around the state.

"Our goal is to establish partnerships between charter public schools and traditional public schools to help spread innovation throughout the entire public school system," she said.

In the mean time, awards will continue to be given annually to charter public schools, like Catalyst, that exceed the standard of excellence laid out by INCS.

When asked why he is running for office Nelson said, "I am running because it is time for a change and new leadership. I want to bring unity to the community. # SMALL BUSINESS OWNERS VOICE CONCERNS AT BUSINESS ROUNDTABLE

Congressman Danny K. Davis presented the small business industry roundtable discussion on Aug.15; this was an opportunity for people to inform Cong. Davis about what should be done to help small businesses. Also people were able to find out about tax credits, incentives, loan programs and opportunities.

The keynote speakers were Patrick Conlon from the state treasurer's office, Carol Harris from the small business administration and Cherly Holman from the Illinois department of employment security. Conlon informed the audience about the numerous programs that the state treasures' office has to offer.

One such program is Opportunity Illinois which deals with community development and consumer loans. Under community development is the "employ Illinois," which gives business owners access to money to start or enhance their business with the help of low-interest rate loans.

Businesses experiencing economic hardships are also eligible to receive employ Illinois loans to assist them in rebounding from tough economic times.

Under state law, the treasurer's office has the authority to deposit state money at a reduced rate of interest in local financial institutions that issue loans at below-market rates for specific projects and programs such as non-profit organizations, businesses and

individuals.

The small businesses that qualify for these loans are neighborhood businesses such as small retail, industrial, export, and contracting firms. The other two loans that are offered under employ Illinois are loans for childcare providers and loans for TV and movie makers.

"If you have a business or are looking to start a business please contact our office." Colon said. The treasures' office also offer three types of consumer loans, one for Illinoisans with disabilities, citizen soldiers, and storm victims.

Carole Harris is the project director at the small business administration (SBA). Harris works with small business development centers to provide counseling and training on how to develop your business such as marketing and keeping financial records. Although they work with many major banks the SBA does not do any lending, but do guarantees for loans.

'What we hope to do is provide people with enough technology, and training by which they can submit an application properly and get a response in three days." One of the major problems that the audience voiced their opinion on is the fact that many people are turned down for loans by banks.

Marcus Matthews from Chase small business banking in Bensenville, the two things that chase looks for is collateral and credit. "I don't want to be the one that said I can't give you the loan based on credit," he said. Also Matthews advised the audience that the first two years for any business is crucial so you must have a cash flow, so his advices to potential business owners "don't quit your full time job."

Cheryl Holman spoke on community assistance programs. These programs trains' people, many of who are in target areas who may not have been hired by some employers, some but not all are ex-offenders. The program does all the training and if an employer hires them, they qualify for tax credits and /or incentives.

Will Edwards from the mayor's office on work force development also discuss the need for businesses to take part in hiring people from target areas to receive tax credits. Cong. Davis closed the meeting by assuring the audience not to give up there dream by giving examples of various community people who started with little, but succeeded.

Cong. Davis will have his State of the District 2007 meeting on Sept. 15 from 9:00 a.m. to 5:00 p.m. at Malcolm X College located at 1900 W. Jackson.





# Cradle To The Grave Program Could Curb Youth Violence

Today's teens are dying from gun shot wounds more frequently than ever before. The rate of death of gun shot teenage victims rose to 30 percent in 1999. Teenagers are twice as likely as any other age group to be victims of violent crimes.

The statistics regarding teenage deaths, especially by gunshot wounds are absolutely sickening," said Charles Frankfurt, researcher for the Children are the Future Violence Prevention Program. "With the rash of deaths this past summer, most noticeably here in Illinois, something obviously has to be done to stop this upward epidemic of negativity resulting in the deaths of children."

One in five of all American teenagers have experienced a violent crime. In 2006, 57,000 people were treated in hospital emergency

Gun violence has been a significant heath problem in the states for years and is growing rapidly not just kids but adults to. Violence exposure studies observed the incidence of or attempted shooting of youth were between 0.5% and 33% estimated that 3,365 youth died from gun shot injuries in one year. # Austin Farmers Market – Healthy Food for the Community

Fresh, healthy produce is a cornerstone of good health and some of the best in the area is available at the Austin Farmers Market, located at Madison and Central. The produce is provided by the Thurman family, who transport the vegetables, fruits and poultry from their 45-acre farm in Pembroke Township near Kankakee, IL.

The Thurman family has been farming for several generations, and bringing their harvest to Chicago has been part of their tradition for many years. The hot, dry weather the past two seasons caused them some problems and they missed the market. But they have returned this year and the bounty is good. Greens, Watermelon, Okra, Sweet Potatoes, Onions, and Green Beans are just a few of the things available at the market. The best part is that they are all grown without the use of chemicals. John Thurman heads the farm and he talks about the beauty of a natural harvest

"We make our living from the soil, so if we weren't in balance with nature then it wouldn't work for us. Because if you're not in balance then you won't produce a good crop," Thurman says. "That's the same reason why we don't use chemicals, because we know at one point that

would run out and the land wouldn't accept it anymore." Respecting nature and not abusing the land are keys to success in farming, but it's not easy raising crops naturally and crops do fail. But that's just a natural part of the growing cycle and you have to live with it, says Thurman.

"You treat it right and it will treat you right," Thurman says of cropland. "Between Mother Nature, us, and the good Lord - sometimes we make a living, and sometimes we just try to make a living, but in the end it's all good."

Eating the naturally grown produce is a welcome change for the body from the chemical bombardment of traditionally grown food. Thurman has some advice for people about their food and consumption priorities.

"People don't educate themselves enough about what goes inside of them as much as what's on the outside of them. They think about the clothes they put on, the deodorant, and the perfumes, but what about what goes on the inside? Good in, good out, bad in, bad out," Thurman says.

The Thurmans are adept at raising a large variety of crops, but they are especially proud of

#### LADRON QUE ROBA A LADRON and petty thief living at a halfway house tip the hand of the script. The viewer can

(\*\*1/2) Loosely translated to mean, "Thief Can Rob a Thief" is quite an entertaining and funny Latino heist comedy with a moral objectivity behind its proceedings. Emilio Lopez (Miguel Varoni) and Moctesuma Valdez (Saul Lisazo) have different philosophies about "stealing". Even though both men share an appreciation for stylish clothing and fast cars. Only one of the two lives in more opulence.

Emilio is a flamboyantly dressed street hustler who calls himself a "freelance distributor" who sells bootleg videos. But its Valdez who amasses a wealthy empire as a high profile scam artist promoting himself as an infomercial guru suckering poor Latino immigrant residents into purchasing his worthless health products.

Emilio visits Alejandro (Alex) Toledo (Fernando Colunga), a recent "illegal alien"

where the owner profits off the immigrants that the two friends manages to bust by stealing his payment..

Soon after Emilio tells Alex of his plan to rob Valdez who lives in a well guarded mansion where an entire floor is dedicated to his money vault that requires; a three number combination, a large key and a magnetic card in his office desk.

Emilio's heist plan includes the usual "motley crew" of experts that provide their own amusing quirks which includes an inept "method" actor hired to pose as a union backer who sets Valdez's non-union immigrant workers to strike outside his offices as a diversion.

Like most heist movies, this one plays itself like a deck of cards. Holding a couple back for the "aha" moment in the finale. Even though, director Joe Menendez tries not to



# **Competition Heats Among Real Estate Lenders**

The strong economy and rapid growth in real estate has produced a massive class of lenders competing for borrowers in an everchanging world of real estate finance.

Real estate lending is in a transition, just like the industry itself, said some experts, who favor floating-rates over a fixed-interest rate right now.

"Borrowers want the best possible deal they can get so it is best for borrowers to take a floating rate over a fixed rate," said Cheryl Smith, an analyst with Atlanta-based Robinson Financial Enterprises Ltd. "Face it, money talks in this business."

Chicago-based real estate adviser King Smith said lending practices remain the same but the players have changed a little bit.

"You have a different breed of lenders today than 30 years ago. Today pension funds and life insurance companies are competing for business with traditional lenders like banks," Smith said. "With this new breed of lenders came a shift from less commercial to more residential lending. Retail and industrial are two other property types a lot of lenders like because they are two future needs."

Smith added that office buildings could become outdated in the future and lenders don't want to be stuck with a piece of property that may take a long time to return their initial investment.

"The market is soft right now for

residential property, which often is less risky than other property types," said Kristy Lockridge, a senior investment officer in the Chicago office of GE Capital, a real estate finance company. "While lenders don't mind taking risks, they also want to minimize that risk and residential property seems to do that."

Keeping a portfolio balanced is something lenders aim for, because no lender wants to be over invested in one area.

"Lenders are looking for more diversification and because there are so many office buildings going up, most lenders have already reached their target for that property type," Lockridge said. "Once that happens they are not as likely to continue lending toward that sector."

Still, lenders are feeling their way back into the current market, testing the foundation of property types and watching Wall Street as they proceed with caution. Regulatory pressures, as well as painful memories of failed portfolios and bad lending deals have persuaded lenders to create no-nonsense underwriting standards.

"The more equity a borrower can put up, the better their chances of getting a lender to finance the rest," said Minnie Gilmore, a former investment banker with Chicagobased Seaway National Bank. "Lenders wouldn't be in this business if they didn't like giving out money to borrowers and taking

risks. However, lenders won't finance a project that won't produce a profit in the end. That's common sense."

Other lenders agree that equity plays a major role in lending.

"When lenders see borrowers willing to take some sort of risk, they are more inclined to fund a deal," said Christopher Carroll, vice president of the capital markets unit at Chicago-based Cohen Financial, a real estate investment firm. "But again, I don't care how much equity a borrower puts into a deal, if the location and credit is not there, the deal still may not happen."

The pressure from competition among lenders has also produced more funding alternatives for borrowers especially when it comes to banks.

The desire to increase profits is the main reason banks have re-entered the direct lending game after years of operating with thin real estate portfolios.

However, some banks now require a loanto-value coverage of 65 percent and 1.3-debt service coverage, although these standards have changed over the last five years. For some mortgage conduits, underwriters want a 70 percent loan-to-value ratio and debt service coverage of 1.35 percent to 1 percent.

Traditional lenders like banks are seeing their once strong hold on commercial and residential lending, quickly falling into the hands of conduit lenders. Conduit lenders are attractive, said some industry observers, because they write non-recourse loans where the borrower is not personally liable. The attractive rates and terms offered by most conduit lenders are driving the lending industry to reshape itself and polish up its act.

"Conduit lenders use long-term money to finance long-term debt and banks typically use short-term deposits to fund long-

From life insurance companies to pension funds, developers now have a variety of choices when seeking funding for a project and the list of lenders seems to grow each

"At the rate things are going now, I wouldn't be surprised if payday loan companies move from consumer loaning to business," Smith said. "Who knows, one day a developer may be able to get a small, \$1 million project financed by a payday loan

NFL superstar quarterback Michael Vick officially plead guilty to the dogfighting charges that could land him in jail for up to five years and cost him his NFL career.

Vick indicated that he would seek a plea agreement on August 23, and then made it official at a hearing on August 27. Directly after the hearing he held a new conference and told reporters and the public how the ordeal has affected and changed him.

Vick took the podium at the news conference with a script but instead spoke freely, without looking at the prepared statement. He was contrite and apologetic as expected, but also seemed very nervous and uncomfortable with the situation. Some of the Key things he said were.

"I want to apologize for all the things I've done and all the things I've allowed to happen. Dogfighting is a terrible thing and I do regret it."

Vick also said "I take full responsibility for my actions, what I did was very immature – I do need to grow up." He also addressed his young fans and stated "And if I'm disappointed with myself more than anything, it's because of all the young people, young kids that I've let down, who look at Michael Vick as a role model. Vick continued by saying "I found Jesus and asked him for forgiveness, and turned my life over to God. And I think that that's the right thing to do as of now."

It's no surprise that Vick tried to say all of the right things with so much weighing against him, but dogfighting is actually extremely common in this country. Here are some interesting facts about it.

\*Dogfighting is a felony in every state except Wyoming and Idaho.

\*An estimated 20,000 to 40,000 people

participate in dogfighting.

\*Dogfighting multibillion-dollar industry.

\*Pit Bulls account for 99 percent of the dog species involved in dogfighting.

\*An average dog fight carries a \$10,000 dollar purse.

The Vick case with Bad Newz Kennels is also not the first time pro athletes have been caught up in dogfighting. A former pro basketball player and a former football player had

issues with the law in 2005.

Former NFL running back Leshon Johnson plead guilty to three charges related to dogfighting and is now serving a five-year deferred sentence. And Former NBA player Qyntel Woods faced possible charges of dogfighting before pleading guilty to a lesser charge of animal cruelty.

People involved in dogfighting are starting to come forward and speak about it, albeit under conditions of anonymity and some have said the "sport" is rampant among professional athletes. Vick's plea agreement stipulates that "the defendant will provide more detailed facts relating to his case during ensuing debriefings," so the truth about Bad Newz Kennels and others involved will probably come to the surface in the coming months.

In addition to the dogfighting charges Vick may also face state animal-cruelty charges. He must also pay for the handling of the 54 Pit Bulls which were found at Bad Newz Kennels. Authorities have said that most of the dogs found there will have to be euthanized because they are too wired for dogfighting and too aggressive to be

Closer to home, Chicago Bears linebacker Lance Briggs is in a bit of a bind after he crashed his new Lamborghini sports car into a pole on the edens expressway in the wee hours of Tuesday morning. Briggs apparently panicked when the accident occurred and fled the scene, only to call police later. Briggs spoke to reporters and offered this assessment of the situation.

"When it happened the first thing I did was, obviously panic. I didn't want there to be a big scene there, so I left the scene. When I left I called the tow truck – I was startled and I reported that my car was stolen. Within

AWAY FROM HER (\*\*\*1/2) Actress Sarah Polley delivers an impressive, yet personal directorial debut backed by the honest and compelling performances of Julie Christie and Gordon Pinsent as this devoted, elderly married couple, Fiona and Grant Anderson whose lives in their Canadian cabin home become altered.



Wilson Jr. comes to realize the real danger they are in from a shootout with two hired assassins that invade the house, but Wilson Jr. is not fully aware of the reasons behind it all until Millie partially explains to her son his late father's association to Javier Cordero (Gary Perez).

"Balls of Fury" is a thinly disguised spoof on Bruce

Lee's 1973 cult favorite "Enter the Dragon" that conceives itself as a kung fu parody set to the seedy underworld of competitive ping pong tournament on a remote Central American island to cover illegal smuggling operation

Dan Fogler plays the one time ping pong child prodigy, Randy Daytona who embarrassed himself during a critical match against cocky East German opponent, Karl Wolfschtagg (the film's co-writer-producer Thomas Lennon who partnered with director Robert Ben Garant are also responsible for cable TV's "Reno 911").

Due to Randy's concentration being distracted by his ex marine father's (Robert Patrick) gambling bet on the match with the Japanese Triad mob. Randy loses the match that leaves to his father's murder.

Now twenty years later, pudgy and full of self doubt working as a novelty lounge act, Randy is brought out of retirement by FBI agent Sgt Ernie Rodriguez (George Lopez) to use his ping pong skills to infiltrate a strange tournament on a Central America island fortress, operated by the flamboyant yet sinister Master Feng (Christopher Walken) to undercover his illegal gun manufacturing operation.

But Feng was also the unseen force behind the triad that had his father murdered that Randy would like to avenge in between his clumsy and inept demeanor. Still, Randy's rusty re-entry into the sport leads to the FBI agent taking him to re-sharpen Randy's skills under the sage teachings of blind master Wong. played hilariously by veteran oriental actor James Hong who has the best comedic lines to steal most of the scenes in this comedy.

Wong happened to by Feng's original teacher before quitting mid-way to begin his evil quest. Wong offers his highly skilled niece, Maggie (Maggie Q) in martial arts and ping pong to senselessly fall in love with Randy during his training preparation.

Dan Fogler, fresh from his Broadway stint in "Putnam Spelling bee" is a likeable butterball full of pratfalls and slapstick abilities. But when he stretches his face and screams; One can't help but see a natural casting candidate if ever a movie biography on the late comic Sam Kinison is made.

"Balls of Fury" is a disposable comedy spoof that we expected to be; that manages to sustain its humor a little longer than anticipated. This isn't saying much since the wit and humor isn't enough against its own "hit and miss' levels to outpace the film.

The movie has its moments, but mostly this is a stupid excuse for silliness done wrong. Even as a straight-up kung fu parody set to table tennis. "Balls of Fury" isn't as distinctive or funnier enough at three times the length that was achieved years ago in an obvious Bruce Lee takeoff skit that was the best and funniest in 1977's "The Kentucky Fried Movie", an early success for Zucker-Abraham-Zucker who gave us "Airplane!" If only "Ball of Fury" could have been "match point" to its processor.

All except Pearson are wanted on criminal drug conspiracy charges. Pearson is wanted for possession of a controlled substance.

Members of the department's Narcotics and Gang Investigation Section (NAGIS) responded to complaints from community residents and began their investigation last December. The focus of the seven-month investigation targeted illegal narcotics activity taking place that was leading to violence and street wars between two rival gangs, the Vice Lords and the Gangster Disciples.

Preliminary 2008 budget can be acquired from the Office of Budget and Management at City Hall

In a phone interview in preparing this story NLCN spoke to Tayor Mitchell. "We're definitely disappointed with the proposed budget cuts regarding CPS," said Mitchell, a member of the Chicago Public Schools financial division. Both the State and the city are grappeling with the overall cuts from the federal government.

North Lawndale Community residents are curious as to how the City Budget is going to affect them. One resident specially brought the Chicago Park District to the forefront. According to the proposed State Budget Numbers, the Chicago Parks District is set to gain upwards of a fifteen percent increase in funds, something that many allude may be in done in a effort to get the 2016 Olympics to Chicago. Marica Carusi, who attended and provided testimony at the meeting said "I would certainly hope that this proposed increased for the Parks District is aimed at keeping our parks clean, the crime down and beautifying our neighborhoods, not just spending money aimed at getting the Olympics and getting money into people's pockets."

City residents had concerns from Park District access to sewers, to cutting of trees on their block. North Lawndale residents were sizeable in their attendance, especially over the newly proposed Ogden Pulaski TIF. Rosalyn D. Brown, the third to speak said "They are going to put a TIF in the Ogden Pulaski TIF, What I'm asking for is an advisory council so we the residents can have something to say." The message of inclusion in decisions on changes in one's community where they live was echoed by other residents that spoke at the hearing. Also receiving applausal support from many in the audience.

Joe Ann Bradley, a candidate for ward democratic committeeman spoke representing the Lawndale Alliance, a group of residents from the North Lawndale area stood up in the crowd to show support. "The people of Lawndale are not all thugs. They are not all dope dealers..... These are people who are honest paying taxpayers. Who are working class for the most part are concerned about this city." Ms. Bradley also asked for an extension for the Conservation Council that is about to expire. She asked that it be extended for the life of the Odgen Pulaski TIF.

The budget seems to be a serious concern in west side communities. Brian T. Roby, a youth counselor and Executive Director of the Community Uplift and Outreach Project said "The lack of support for the not forprofits that are out here trying to make a difference is really troublesome. There's no reason why we shouldn't be a focal point of the budget, as we provide a lot to the community that the city offices claim to want to improve. Hopefully there are some changes made to the budget so that money is more widespread in community development."

the greens that they grow. Thurman sees greens as a wonderful product for the taste and the health benefits as well.

They have beta carotene and it's just good for you. Greens keep you flushed and everything moving. And they've got a lot of vitamins that you wouldn't get otherwise." Thurman cautions people to not overcook their greens because "the longer you cook them the more nutrition you lose."


Farming is a tough business and it takes a lot of dedication and fortitude to keep going through the tough times on the farm, but Thurman loves being in a rural environment and thinks it's good for the physical and mental well being of most people.

"It's a good, clean atmosphere if you've got kids – if you don't it's easy breathing for yourself," says Thurman. "It's hard but it's fare...it's just that simple. He adds, "It may not have all the amenities that you're used to, but if you want to live longer, in a laidback, quiet atmosphere then that's for you. But if you like the rush and the noise and the hustle and bustle, then you might as well stay in the city."

The Thurman's fresh, naturally gown produce should be around for a long time, and right now there are 11 family members between the ages of 12 and 29 who work on the farm. His 22 year-old daughter is closing in on buying her own land in Pembroke and his sons are working at other trades to make the transition to farming less financially daunting. The Thurmans are simply dedicated to farming.

"Farming with us is just what we do. It's not just a way to make money. it's a lifestyle, and it's what we desire," Thurman says. The Austin Market is open every Saturday from 7:00am until 2:00pm. It's located near the corner of Madison and Central in the parking lot of Emmit Math, Science and Technology parking lot.
